Extinguishing Media:	Use alcohol resistant foam, carbon dioxide, dry chemical, or water spray when fighting fires. Steps to Take in Case Material Is Released or Spilled:	<p>Exposure to the spilled material may be severely irritating or toxic. Follow personal protective equipment recommendations found in Section 8 of this SDS. Personal protective equipment needs must be evaluated based on information provided on this sheet and the special circumstances created by the spill including; the material spilled, the quantity of the spill, the area in which the spill occurred, and the expertise of employees in the area responding to the spill. Never exceed any occupational exposure limits. Avoid breathing dust/fume/gas/mist/vapors/spray. Ventilate the contaminated area. Evacuate the area promptly. Isolate area. Keep unnecessary personnel away. Evaporation of volatile substances can lead to the displacement of air creating an environment that can cause asphyxiation.</p> <p>Prevent the spread of any spill to minimize harm to human health and the environment if safe to do so. Wear complete and proper personal protective equipment following the recommendation of Section 8 at a minimum. Dike with suitable absorbent material like granulated clay. Gather and store in a sealed container pending a waste disposal evaluation. A large(uncontrolled) release should only be handled by a specially trained spill brigade or by a qualified contractor. Use an inert absorbent such as sand or vermiculite. Place in properly labeled closed container. Shut off ignition sources; including electrical equipment and flames. Do not allow smoking in the area. This material is a water pollutant and should be prevented from contaminating soil or from entering sewage and drainage systems and bodies of water.</p>
